Warranty

ABB Installation Products Inc. (Formerly Thomas & Betts Corporation) sells this product with the understanding that the purchaser will perform all necessary tests to determine the suitability for the user's intended application. Subject to the limitations set forth below, ABB Installation Products Inc. warrants that the Hazlux H3 LED luminaire (the "Product") will be free from defects in material and workmanship for a period of five (5) years beginning on the date of installation or 90 days from the date of shipment, whichever date is earlier (the "Warranty Period").

Warranty Limitations and Exclusions:

The above warranty shall only apply when the Product is installed in applications in which ambient temperatures are within the range of specified operating temperatures and is operated within the electrical values shown on the LED driver label. This warranty is also void if the Product has been subjected to misuse, neglect, accident, fire, physical damage, improper installation, unauthorized modification, or use in violation of our instructions or any applicable laws, codes or ordinances.

Conditions of Warranty Limitations and Exclusions:

(1) The purchaser shall submit all alleged claims or defects within the Warranty Period to ABB Installation Products Inc., in writing and with detail of the same; (2) the purchaser shall at its sole cost and expense return the Product with a bill of sale or other evidence showing the date of purchase and identification of the original purchaser; (3) if upon inspection and testing of the returned Product by ABB Installation Products Inc., such Product is found to be defective and such defect has not been caused by the exclusions detailed above, ABB Installation Products Inc. shall, at its sole discretion, repair, replace or refund such Product; and (4) the purchaser shall prepay all of ABB Installation Products Inc.'s expenses (including risk of loss) for the delivery of all repaired or replaced Products to the purchaser. ABB Installation Products Inc. reserves the right to replace any warranted Product with a substitute product of similar function if the warranted Product is no longer available.

THE ABOVE WARRANTY IS THE SOLE WARRANTY CONCERNING THIS PRODUCT, AND IS IN LIEU OF ALL OTHER WARRANTIES EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, WHICH ARE SPECIFICALLY DISCLAIMED. LIABILITY FOR BREACH OF THE ABOVE WARRANTY IS LIMITED TO COST OF REPAIR OR REPLACEMENT OF THE PRODUCT, AND UNDER NO CIRCUMSTANCES WILL ABB BE LIABLE FOR ANY INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES.
